# MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES PERMIACARE

The regular monthly meeting of the Board of Trustees of PermiaCare was held February 15, 2022, at 401 East Illinois Avenue, Midland, Texas, 79701 and via Zoom at 3:30 PM.

#### I. <u>CALL MEETING TO ORDER</u>

Chair Jones declared a quorum and called the meeting to order at 3:31 p.m.

#### II. CHAIR'S REPORT

Chair Jones asked if there were any public comments. There were no public comments. CEO Barnhill introduced Jade Womack who is our CCHBC Manger.

#### III. PRESENTATIONS/TRAINING

Jade Womack presented an overview the impact of CCBHC Expanded Services. The SAMHSA CCBHC expansion grant has provided PermiaCare the ability to

increase available staff and expand the current services array. In addition, we have expanded partnerships with medical and substance use agencies in our communities which did not exist previously. A CCBHC Advisory Committee has been established to provide an opportunity for community stakeholders and consumers to gather once a month to discuss PermiaCare services. Mrs Womack asked if there were any questions, there being none she thanked the board for their time. CEO Barnhill praised her for all that she has done in helping expand services for our clients.

CEO Barnhill reported the Health and Human Services Commission (HHSC) offers an opportunity through the All-Texas Access Regional Groups to host a Sequential Intercept Mapping (SIM) Workshop in our community. These workshops identify weak points across six intercepts to improve the treatment of justice involved individuals who have mentally illness and/or

intellectual disabilities. PermiaCare is set to host our first SIM workshop for Midland County on May  $16^{th}$  &  $17^{th}$ .
